Schools must provide age appropriate lessons that will enable pupils to make informed decisions about their wellbeing, health and relationships and to build their self-efficacy in making decisions about risks, challenges and complex situations. It is a safeguarding curriculum that builds pupils' resilience, skills and confidence to access support when needed.

As a part of your child's education at Winifred Holtby Academy, we promote personal wellbeing and development through our comprehensive Personal, Social, Health, Citizenship and Economic (PSHCE) education programme. I am writing to let you know that, during Spring term 2, your child's PSHCE group will be taking part in lessons which will focus on the Relationships and Sex Education (RSE) aspect of this programme. RSE lessons in Year 8 focus on teaching about 'Commitment', 'Making your Own Choices'; 'The Impact of Social Media on Health' and Gender Identity & Sexual Orientation'. Pupils will also have opportunities to ask questions that help prepare them for relationships of all kinds in the modern world. PSHE education is taught throughout the school in every year group and is monitored and reviewed regularly by the staff and governing body. All RSE teaching takes place in a safe learning environment and is underpinned by our school ethos and values. Please visit the school's website for more detail about our RSE & Health curriculum.
